Terms and Conditions of Enrolment & Re-enrolment

- An Application for Enrolment Form must be completed for each new pupil.
- We will endeavour to allocate a space on the scheme to suit your requirements. If, however, this is not possible, you will be added to a waiting list and we will inform you when a space is available.
- An Application for Re-enrolment Form must be completed for pupils wishing to enrol for a further course. Parents / Guardians must advise of any changes in personal details at this time.
- Spaces are guaranteed for pupils already on the scheme who wish to re-enrol for a further course of lessons. However, preferred levels, dates and times cannot be guaranteed. We reserve the right to nominate specific levels for pupils.
- Confirmation of enrolment on the scheme cannot be confirmed until payment has been received.
- Terms and conditions of membership are also applicable to those paying by Direct Debit.
- If a lesson is cancelled by the centre, at the Managers discretion a credit note will be issued against the following months payment, if the course is being paid for by Direct Debit
- Refunds will be given in the form of credit notes at the Managers discretion on the grounds of medical reasons only.
- The number of lessons in any given term may vary due to the number of weeks in a month or bank and national holidays.

Etiquette & Important Information

- If the pupil has had diarrhoea within the last 14 days, they should not swim. Please notify the teacher if this is the case.
- If the pupil has vomited in the last 24 hours or is suffering with a cold or virus, then please do not use the swimming pool.
- In order to maintain hygiene within our pools, please ensure your child(ren) has been to the toilet prior to the lesson. Swim nappies must be worn by babies and toddlers in nappies. These are available to purchase from Reception.
- If pupils have a verruca, please obtain treatment available from a pharmacist, try to keep it covered and avoid walking barefoot in the shower or changing room areas.
- Please ensure the pupil showers before entering the pool.
- Please ensure the pupil is wearing sensible bathing attire, e.g. no baggy shorts or swimsuits with frills or accessories.
- For safety reasons, swim hats depicting the class level must be worn throughout the lesson and should be fitted prior to the lesson. The swim hats contain a small amount of latex. Please advise if your child has an allergy to latex.
- No jewellery apart from plain stud earrings and plain band rings should be worn.
 - Goggles meeting British Standard BS 5883:1996 may be worn. These are available to purchase from reception. However, they must fit correctly and Parents / Guardians must ensure they are adjusted prior to the lesson as teachers will not be responsible for fitting them. Please note that the teacher may ask for them to be removed on occasions to allow the child to get used to water in his/her eyes.
- 'Meet and Greet' areas will be designated to ensure the safe transfer of children to and from the lessons. Please ensure you bring your child to the designated area at the start of each lesson and are available to meet your child at the end of the lesson.
- Parents / Guardians are responsible for the supervision and primary care of their child(ren) whilst in the lesson. Teachers reserve the right to remove any child from a lesson who is misbehaving or causing disruption for other children.
- Parents / Guardians must remain in the building throughout the lesson and ideally stay within the designated spectator area throughout the lesson.
- No parents / guardians are permitted on poolside during lessons unless this area has been designated as a spectator area. Where this is the case, no outdoor footwear will be permitted or overshoes provided must be worn.
- Parents / Guardians must avoid speaking to the pupils or the teacher during the lesson
- In the event of an emergency, all Parents / Guardians and spectators of swimming lessons must comply with the instructions given by centre staff. In the event that the building needs to be evacuated, the pupils may be required to leave from a different exit under supervision of centre staff. Parents / Guardians should leave by the exit as instructed and meet their child(ren) at the designated assembly point.
